COUNT(S) 3 IS/ARE DISMISSED. COURT ACCEPSED. DEFENDANT'S GUILTY PLEA. THE COURT CONSIDERED ALL REQUIRED FACTORS OF THE LAW. AS A RESULT OF THE CONVICTION(S) IN THIS CASE AND THE IMPOSITION OF A PRISON SENTENCE, AND PURSUANT TO R.C. 2967.28(F)(4)(C), THE DEFENDANT MAY BE SUBJECT TO A PERIOD OF POST-RELEASE CONTROL OF: UP TO 2 YEARS OF PRC AT THE DISCRETION OF THE PAROLE BOARD. THE ADULT PAROLE AUTHORITY WILL ADMINISTER THE POST-RELEASE CONTROL PURSUANT TO R.C.2967.28, AND THE DEFENDANT HAS BEEN ADVISED THAT IF THE DEFENDANT VIOLATES POST-RELEASE CONTROL, THE PAROLE BOARD MAY IMPOSE A PRISON TERM AS PART OF THE SENTENCE OF UP TO HALF OF THE STATED PRISON TERM OR STATED MINIMUM TERM ORIGINALLY IMPOSED UPON THE DEFENDANT IN NINE-MONTH INCREMENTS. IF WHILE ON POST-RELEASE CONTROL THE DEFENDANT IS CONVICTED OF A NEW FELONY, THE SENTENCING COURT WILL HAVE AUTHORITY TO TERMINATE THE POST-RELEASE CONTROL AND ORDER A CONSECUTIVE PRISON TERM OF UP TO THE GREATER OF TWELVE MONTHS OR THE REMAINING PERIOD OF POST-RELEASE CONTROL. THE COURT FINDS THAT A COMMUNITY CONTROL / PROBATION SANCTION WILL ADEQUATELY PROTECT THE PUBLIC AND WILL NOT DEMEAN THE SERIOUSNESS OF THE OFFENSE. IT IS THEREFORE ORDERED THAT THE DEFENDANT IS SENTENCED TO 5 YEAR(S) OF COMMUNITY CONTROL / PROBATION ON EACH COUNT, UNDER SUPERVISION OF THE ADULT PROBATION DEPARTMENT. THE DEFENDANT MUST ABIDE BY THE RULES AND REGULATIONS OF THE PROBATION DEPARTMENT IN ADDITION TO THE FOLLOWING CONDITIONS: COURT ORDERS DEFENDANT TO BE SUPERVISED BY: REGULAR SUPERVISION UNIT VIOLATION OF THE TERMS AND CONDITIONS MAY RESULT IN EXTENSION OF THE PERIOD OF SUPERVISION, MORE RESTRICTIVE SANCTIONS, OR A PRISON TERM OF 17 MONTHS AS APPROVED BY LAW. THE DEFENDANT IS REFERRED TO THE COUNTY PROBATION DEPARTMENT FOR A POST-SENTENCE INVESTIGATION AND REPORT. SUPERVISION FEES TO BE PAID AT A RATE OF \$20.00 A MONTH. RESTITUTION ORDERED IN THE AMOUNT OF \$3,187.99 TO CUYAHOGA COUNTY SHERIFF'S DEPARTMENT; PAYABLE THROUGH THE PROBATION DEPARTMENT. THE DEFENDANT IS ORDERED TO PAY A FINE IN THE SUM OF \$ 12,000.00.
