**Convicted — disorderly conduct / intoxication persisting, on a plea of no contest to a reduced charge. Fine \$150. Restitution ordered to Cathy Stark: \$605.99. Probation ordered (monitored, inactive). Costs \$470.29.**

*The disposition record shows jail time of 30 days against this charge; the docket records probation rather than any committal. **The restitution was paid** — the court paid it out to the victim on 29 March 2021 and cancelled the alert. The case-information page still shows a \$605.99 balance, carried under costs, not as restitution owing.*
